

WDSLA completed landscape design and construction documentation for a new 148 lot residential subdivision at Serrano (Serrano Village 6, Phase 1 & 2 Streetscapes) in El Dorado Hills, California. The scope of work included the development of Landscape Construction Documents to obtain building permit approval for the project.

The project included design of landscape and irrigation for all public perimeter streetscape frontage areas and medians along both Sienna Ridge Drive and Bass Lake Road, Phase 2 water quality basins, Phase 2 'native transition' area to Bass Lake, Phase 2 entry extension at Bass Lake Road, as well as privately maintained gated entries and interior landscape of both phases.

WDSLA worked with the Glide Foundation to design and construct new landscape improvements at the 1.3 acre property. The site and landscape design supports the historic architectural aesthetics of the buildings and lends itself towards a design approach similiar to the nearby Pierce Ranch Road property. Low water use and low maintenence plant materials were favored, while staying true to the garden aesthetic requested.

WDSLA developed conceptual design plans, defining all paving, amenity and landscape areas, followed by a Landscape Document Package, satisfying Water Efficient Landscape Ordinance legislation, as required for Yolo County review and approval for the project.

WDSLA provided Preliminary and Construction Document level design services for this 0.30 acre turn-key pocket park at The Promenade development in West Sacramento. The park includes a corner plaza with passive seating, a central shade structure with group seating and BBQ amenities, children's play area for 2-5 and 5-12 age groups, a bocce court and an informal turf area for unstructured play.

The park was designed to be overlooked by the developer model homes during active sales, but is now the extended front yard for these centrally located homes and the recreational gathering and connection space for this 222 unit community.

This recently completed Park Master Plan provided a much needed community gathering and event space with parking for 70 cars, a large group picnic shelter, children's play area, restrooms, a little league baseball field, a large turf soccer field, a basketball court, volleyball court, and perimeter walking path with multiple seating and exercise stations.

WDSLA was contracted to assist the community in developing the Park Master Plan and Proposition 68 grant application for potential construction funding as a low income and underserved population in Yolo County. 8 community meetings and workshops with local stakeholders of all ages became the backbone of critical input as the Park Master Plan was developed. Construction Documents are now underway for Phase 1 construction during the spring of 2023.

WDSLA provided landscape design to obtain permitting for a new design-build Science and Biotech Building, located on the Solano Community College campus in Vacaville, California.

The scope of work included the development of a Design Development Landscape Plan for overall project team review and approval, followed by Landscape Construction Documents to obtain building permit approval for the project. The landscape design followed previous conceptual design and plant quantities used by the design-build contractor to successfully bid the project. The process also allowed for collaborative input by architectural design team members to meet the project's overall design intent, while adjusting to final site design elements still being determined during the design-build process.
